The Vicar of Christ Church, Rev Canon Steven Asirvatham, as the Chairman of the AGM welcomed the members present. He opened with a word of prayer followed by singing 'Great is Thy Faithfulness' remembering all the blessings God has bestowed upon Christ Church.

2.0 Chairman's Message

2.1 Great is the Lord and most worthy of praise; his greatness no one can fathom. One generation commends your works to another; they tell of your mighty acts. They speak of the glorious splendour of your majesty— and I will meditate on your wonderful works. Psalms 145:3-5.

Greetings in the wonderful and matchless name of our Lord and Saviour Jesus Christ. We praise God for last week's Pre-AGM meeting and specially want to thank all those who participated in it.

As we gather for our Virtual Parish Annual General Meeting, let us bring to our memory all that the Lord has done for us, as mentioned by the Psalmist in Ps.145:3-5. There are many things that we ought to give thanks and praise to the Lord.

On a personal note, I am grateful to God and to every one of you, for remembering me and my family in your prayers, when I went through heart by-pass surgery. It is indeed the great mercies of God and the prayers of saint that led me to a speedy recovery.

As a Parish, we are thankful to the Lord for leading us over the past two years during the pandemic. We had to be cautious in following all safety regulations given by CPRO and the Diocese. Since we are situated in an open area, we had to be extra careful to avoid being penalised. Nevertheless, we thank God for bringing us back to worship as a Church, with relaxed regulations. However, let us remember that we are still under Covid regulations and therefore need to conduct ourselves responsibly. I wish to specially thank all volunteers who had stepped forward to help assist in the safety management team led by Ps Moses Ajay and Bro Daniel Dharmaraj. You came forward to go the extra miles so that others could worship the Lord. I also wish to thank all volunteers and members from the different services for your cooperation and understanding and during the pandemic.

A special word of thanks to the Audio-Visual team led by our Wardens for their sacrificial effort in ensuring live streaming of our service, since the pandemic begun, as requested by the Diocese. I have taken note of your comments on the way the safety measures were put into action in our parish. But above all, I want to thank all members of our Parish for your sincere understanding and cooperation as we sailed through this difficult season. It is our prayer that God in His mercy will not let us go through another season of restrictions in worship. I wish to inform all members that Bishop Titus during our recent Synod meeting held on 21st May 2022, has decided to cease all online Holy Communion service from 30th June 2022.

We thank God for the life and exemplary service and ministry of our late Chancellor Mr Richard Magus who went to be with the Lord on 14th March 2022. But I am glad to inform all that Bishop Titus announced the appointment of Dr Stanley Lai as the new Chancellor of the Diocese effective from 21st May 2022. Kindly uphold our new Chancellor and the leadership of the Diocese in your prayers.

We must give thanks to the Lord for His unfailing love and providence in the completion of redevelopment project of the education block. When the work begun, we were hit by Covid which became a grave concern for all of us, as the delay may have financial implications.

However, today the newly redeveloped educational block stands as a testimony that it was the Lord who has led us to finish this good work of the Lord. I am grateful to the Parish Redevelopment committee led by Mr. Thomas Jeyaseelan, for the many hours and effort put into this redevelopment project. Together with the outgoing PCC, I want to specially acknowledge the tireless contribution of Mr. Jeyaseelan who caringly coordinated with the several parties involved in this redevelopment project. At the same time, I want to sincerely thank everyone in our Parish who had generously contributed and still contributing towards this work. The work is far from over as we still must serve the \$1million interest free loan from the Diocese. Therefore, I urge all of us to continue supporting the fund-raising efforts of our Parish Fund Raising Committee led by Mr. Christopher Samuel.

After much prayer and in consultation with Bishop Dr Titus Chung and the PCC, we decided on renaming this education block as Canon Samuel Baboo's Block. When we read scripture, many names are mentioned and each of these names has a story, about what God has done through these individuals. In the same manner, we remember Canon Samuel Baboo who had significantly contributed towards the early development of Christ Church as well as overall development of the Indian work in Singapore and Malaysia. The story about Canon Baboo is also the story of our forefathers who had co-laboured with Him during the challenging years of our parish. But above all, this is the story of God at work in the life of His servant as well as the people of God.

This story is unique to us as the family of God in Christ Church and as such the Psalmist exhorts us to proclaim it to the generations to come in Ps. 145:4 – "One generation commends your works to another; they tell of your mighty acts."

Dear brothers and sisters, this story of God at work in Christ Church is something that we are to remember with thanksgiving and tell it to the younger generations. Just like the people of Israel who told of the mighty acts of God in the bible, this is our story of God's might act in the life of Christ Church.

Canon Samuel Baboo's Block stands today as a testimony and reminder to us and the generation to come, about God's faithful providence and sustenance of His Church. He who begun this work is faithful to us to the end. Amen.

As we give thanks to the Lord for this new building, we are also aware of the challenges ahead of us. The operational and maintenance cost will incur extra expenses on top of servicing the interest free loan from the Diocese. Nevertheless, let us remember God's faithfulness in the past as well as today. He will lead us as we put our trust in Him.

The people of God were terrified by the chasing army of Pharoah as well as the Red sea before them. But the Lord was faithful to make a way for His people. There was great joy when they crossed over to the other side. However, that was not the end of the story. The people of God had to overcome many challenges before possessing the promise land. In the same way, we will face new challenges in the days to come. May the Lord turn every challenge into new opportunities for us to glorify Him.

God has provided us this new building at a very important time in the life of His Church. The government has announced new housing blocks and private condominiums at the present Farrer Park site. With these new residents coming at proximity of our Parish, we see the possibility of opportunities for new ministries and worship services. Let us prayerfully seek God in fulfilling His purpose for giving us this new building.

We thank God for the ministry of Prison Fellowship of Singapore (PFS) who are presently in the process of moving into the third floor of Canon Samuel Baboo's block. Some of our members are involved in the ministry of PFS in reaching out to the families of inmates. Let us uphold this ministry in our prayers and help to reach broken lives for Jesus.

On the mission front, God has been good to help us support mission agencies and missionaries in India as well as Myanmar. I want to thank our missionaries to Nepal, Bro Sandrabose and Sis Vasanthi for the presentation and on the work. We praise God for His providence of a new land for Joy Land Kindergarten

as well as Christ Church Pokhara. Due to the pandemic, Bro Bose and Sis Vasanthi were not able to travel to Nepal since their return in 2020. Nevertheless, they continued to work among Nepali speaking Indians working in Singapore through Ps. Kris from Grace Church. There is a sizable Nepali speaking Indians working in Singapore which I ask all of us to pray and reach out.

In 2021, I took on the role of Dean of Nepal but due to my health, I had requested our Diocesan Bishop to relieve me as Dean of Nepal. Therefore, Bishop Dr Titus Chung has appointed retired assistant Bishop Kuan Kim Seng as Acting Dean from 1/5/2022. However, the new acting Dean has requested me to continue being part of the Deanery Council of Nepal in Singapore. He has requested me to head the education ministry in the Deanery of Nepal. Therefore, I seek your prayers for the mission work in Nepal. Please pray for Bro Bose and Sis Vasanthi who are trying for long term visa to minister in Nepal. I want to thank members of our parish who came forward to support our missionaries through financial support from September 2018 to 2020. Since then, some have continued to support while many have ceased to give. I will be writing again to all parishioners, urging to support this missionary couple whom the Lord has called and set apart for Nepal. Please support them through your prayers as well as your giving.

Finally, I want to emphasise on the Parish Discipleship Journey which the pastoral team shared at the Pre-AGM. The vision is to see every member of our Parish be, "Discipled to become Disciple". This call to Personal Discipleship was made by our former Bishop The Rt Rev Rennis Ponniah, as part of the "Celebration of Hope". Our present Bishop The Rt Rev Dr Titus Chung has reiterated that his ten-year focus is to lead the Diocese towards Discipleship.

Since 2020, I had been exploring together with my pastoral team, on possible tools and methods of coming out with a discipleship process for our Parish. The Navigators Singapore which is a parachurch organisation has been helping Churches over the years in Discipleship. After many months of consultation and trainings, we have planned to begin the Personal Discipleship Journey (PDJ) from this July onwards. Those who are keen to join this PDJ are kindly advised to give your names to Ps Theodore or Ps Moses Ajay.

Due to this PDJ process, there will be some adjustments to some of our existing programs. We seek your understanding and cooperation as we move towards the vision of becoming a Parish which will be Discipled so that we can make Disciples for Jesus our Lord.

Finally, let us therefore give thanks to the Lord for this new season, which I am confident in the Lord will lead to healthy spiritual and numerical growth in our parish life. But this requires individual commitment on our part so that the Lord can bless us. Amen.

They are also responsible for providing the technical support for today's Webinar session.
- c. The Pre-AGM will be recorded, minutes will be taken and provided in consolidation with the AGM minutes which will be held on 4 June 2022.
- d. All amendments, questions, clarifications and resolutions must have been submitted by Electoral members by 21 May 2022, 7pm.

7.0 Presentation – Nepal Missions by Mr Sandrabose and Mrs Vasanthi Sandrabose

- 7.1 Mr Sandrabose and Mrs Vasanthi presented on the following areas:
 - their Covid and post Covid experiences
 - their two key tasks which is to support Christ Church Pokhara and Joy Land Kindergarten.
 - future plans for a permanent place for Christ Church Pokhara and Joy Land Kindergarten
 - support for Anglican Church of Nepal Future Projects and Plans in Nepal

Please refer to **Appendix 1** for a detailed account of their sharing. Continue to cover them, all future plans and their ministry in prayer.

- **7.2** Mr Aaron Masih extended his appreciation for the work done in Nepal by Mr & Mrs Sandrabose. He requested for the following to be considered:
 - conduct language and culture related training to better equip members before mission trips
 - conduct more regular mission trips so that members across all the services can participate
 - set aside budget to support members to attend mission trips

Missions and Evangelism Committee will look into these suggestions.

7.3 Mr Rufus thanked Mr & Mrs Sandrabose for the work they do in Nepal. Mr Sandarbose mentioned in his presentation that there are anti-conversion laws and anti-Christian sentiments in Nepal. How then did we manage to purchase a land for the church. Mrs Vasanthi explained that the land purchased is for the school which is licensed and registered with the government hence there are no concerns. The kindergarten and church will coexist but will be demarcated by a fence. The church will be heavily involved in community-based projects, counselling, family support and education besides doing evangelism.

8.0 Presentation – Redevelopment Project Update

Mr Thomas Jeyaseelan presented the update.

- 8.1 Thanks to God for His indescribable gift and the following:
 - BCA awarded the Temporary Occupation Permit (TOP) on 22 March 2022.
 - The Certificate of Statutory Completion (CSC) was obtained on 18 April 2022
 - The Project is completed on 25 April 2022
 - Level 3 has been taken over by us and handed over to Prison Fellowship Singapore (PFS)
 - Levels 2 & 4 have also been taken over and minor corrective works are in progress
 - Level 1 takeover will be on 30 May 2022
 - The two lifts are operating regularly

8.2 Next Phase

8.2.1 Closure of Accounts

- Architect and Quantity Surveyor (QS) are working on the final accounts for the Project.
- Extension of Time (EOT) claims received from the Main Contractor are being evaluated.

8.2.2 Maintenance Period of 15 months

- Begins from 25 April 2022
- Contractor's obligation: to make good of any defects, omissions or other faults which may become apparent in the works.
- At no cost, if the said defect is due to any breach by the Contractor of any of his obligations under the contract.

8.4 Challenges Faced

- Presence of Asbestos Removal costed us 2 months delay & \$40,000.
- War Relics Disposal costed us \$17,000.
- COVID-19 Pandemic Circuit Breaker. Work ceased from 7 April 2020 to 9 July 2020. Major problem with the roof of the existing 4-storey building. Cracks on hollow slab beyond repair. New roof was cast. Levels 1-3 ceiling reinforced with steel beams. Unforeseen expense of \$228,442.
- Praise and thank God for His mercy & grace to deal with all these and other technical challenges.

The Treasurer explained that it was done as part of reconciliation. Development Fund - Refer to Pg 22

Development Fund: Difference of 500k - 2 fixed deposits of 250k of Development Fund which were approved by PCC in the earlier years to transfer to Redevelopment Fund is corrected now. This is disclosed in page 22 and 28 of the audit report.

Difference of 1.14 million - The sale proceeds of Hertford Mansion plus interest totaling S\$1,141,408.00 which was approved to be transferred to Redevelopment Fund. This was transferred to the Redevelopment Fund and corrected now. This is disclosed in page 28 of the Audit Report.

The Treasurer further clarified that only when the restatement and reconciliation is done are we able to state the exact bank balances for each of the funds. As highlighted by Mr Rufus, this restatement should have been done in 2021. Refer to Pg 28 of the Audited Financial Statements 2021. The Treasurer confirmed that all necessary adjustments have been done.

13.2 General Fund Income: P5

- **13.2.1** Mr Rufus asked What was the other income received from Church of the True Light \$15,600. Treasurer responded that it was Pastoral Services \$1300 * 12 months.
- **13.2.2** Mr Rufus asked if we received any other income from Church of Epiphany. Treasurer responded that it was adjusted in the invoice from Diocese.

With reference to 9.2.2 Treasurer responded to Mr Rufus that the other income is one third of the Clergy's salary. Church of True Light transfers money directly to Christ Church for pastoral services provided while Church of the Epiphany transfers the money to Diocese because it is an appointment by the Diocese which is then adjusted and invoices into the Clergy's salary. This is not to be considered as an income. No quota is paid for the amount received from Church of True Light as it is services provided.

13.3 General Fund Expenditure: P6

Mr Rufus queried what was the line item, 'receipt of \$900 under Medical Fund'.

Treasurer responded that it was the Refund of Insurance Premium for Clergy from Diocese.

13.4 Property, Plant and Equipment: P18

- Mr Rufus requested for details of following additions during 2021:
 - PA System & Audio \$21,719

Treasurer responded that it comprises of sound mixer, amplifiers, entire wiring. The original sound system was installed in 1999. Replaced due to a major failure.

13.5 Property, Plant and Equipment: P18

Mr Rufus if the line-item Furniture and Fittings was budgeted the year before Furniture & Fittings - \$69,476.

13.6 Property, Plant and Equipment: P19

Mr Rufus referred to the following and wanted to know why there was a discrepancy: Accounts software Net carrying amount 31/12/2020 - \$0 (Based on 2020 auditor's report) Accounts software as of 01/01/2021 - \$4278 (Based on 2021 auditor's report)

The Treasurer explained that the total cost of the accounting software was \$4278 which is fully depreciated in the previous year. Hence the net carrying amount is nil (Refer page 20 of the Financial Statement).

13.7 Development Fund: P22

Mr Rufus referred to the Water & Electricity increased by \$27,509 from \$37,729 to \$65,238 and wanted to know why the cost went up by 73%.

The Treasurer explained that it is due to the increase in the Tariff Rate in Y2021 and also due to the usage of the new block.

13.8 Building Redevelopment Fund: P24

Mentioned as Development Fund in the auditor's report. Interest on Fix Deposit is stated as '- (2464)'. Mr Rufus wanted to know why the amount is stated as a negative number.

The Treasurer responded that it is the over recognition of interest for Fixed Deposit in previous year which was corrected this year.

Mr Rufus queried on why Fixed Deposit interest amount needs to be estimated and then adjusted. Treasurer will clarify on this with the Auditors.

13.9 Office Expenses: P25

Mr Rufus referred to the line item 'Printing, Stationery and Office supplies' and asked why it has increased by \$5030 and requested for details.

Treasurer responded that it refers to the purchase of wine, wafer and altar linen laundry. Previously it was captured under Church Mission & Other Expenses: Altar – Linen & Wine. In the current report it is indicated under self-financing activities together with Altar related expenses like Altar Flowers. This will be highlighted to the Auditor.

13.11 Lease commitments – As Lessor P26

Mr Rufus noted that within 2 to 5 years it has dropped from \$337,430 to \$50,350 and wanted to know why there is a drop of \$287,080.

Treasurer responded it is based on the validity of the agreement (Agape) till 31 May 2023. The income receivable is calculated based on 5-month period. The agreement for Vanadium is valid till 31 July 22 (within one year).

13.12 Diocesan Quota – P26

Mr Rufus queried why the amount paid to the diocese is not indicated.

Treasurer responded that the amount is indicated on page 6 of the Financial Statement. This note is only an elaboration of the amount indicated on page 6.

13.13 Mission Fund: P23

Mr Rufus referred to the table below on Church planting in Nepal and noted that the church planting amount has been dropping every year. This was our 75th Anniversary vision and wanted to know what is the plan to raise the fund to build the church in Nepal?

Missions and Evangelism Committee responded that the figures below on <u>P23</u>, referred to the balance of specific donations received in previous years to support Christ Church Pokhara. We have been using these funds to support a Parish worker with SGD 150 per month.

So far, Christ Church Pokhara has been operating from rental premises, and we have been supporting them with operational costs and support of the Parish Worker there. In addition to our homegrown missionaries, we have been helping to establish the Kindergarten and the Church at Pokhara. Concerted effort has been taken, spearheaded by our missionaries Bro Bose and Sis Vasanthi, to find a suitable land for the Church and the Kindergarten. In May 2022, the land was identified, and the purchase of land is for both Joy Land Kindergarten and Christ Church Pokhara through the Deanery of Nepal.

The estimated budget presented for the Pokhara Church Building project by Bro Bose is SGD 250,000. We have started setting aside funds for the Building Project from the available Missions Fund. Since this was confirmed only in May 2022, Missions and Evangelism Committee will deliberate and work on further Fundraising plans.

Mr Rufus requested Missions and Evangelism Committee to consider the following:

- Review all existing missions support and consider if we should continue to support them
- Divert/set aside money for the church building in Pokhara

13.14 Actual expenses 2021 & Budget 2022 - General Fund 2022

Mr Rufus referred to the General Fund 2022 and requested for details as to why the Church Ministry and Other expenses increased from 86,773 to 231,891.

Treasurer responded that the following items were considered in the Budget:

- a. To accommodate cost increase in Utilities (PUB-reimbursement), Insurance Premium, Audit Fees, Church activities that includes Dedication/Farewell Services, Self-Financing activities, Repairs & Maintenance.
- b. \$12,000 was set aside for COVID-19 related expenses if needed.

Mr Rufus observed that the budget for 2022 seems mostly negative leading to a deficit budget which may deplete the reserves. Hence, he hoped for the church activities and self-financing activities to be reviewed so that the deficit budget can be managed.

13.15 Organization Fund 2022

Mr Rufus asked why there was an increase from \$1,256 to \$10,450 for Organizational Fund.

Treasurer responded that more events were planned for 2022 by the ministries. This was in comparison with pre-covid times where in Year 2019 it was \$8,844.

13.6 Mission Fund 2022

Mr Rufus queried on the line item 'SCDF requirement of \$15,000'.

Treasurer responded that it was for the maintenance of fire safety equipment, changing of fire hose reel system, exit/emergency lights system as required by SCDF and certified by a Qualified Professional.

13.20 Building Development Fund 2022

Mr Rufus queried on the line item 'Facility Management of \$28,800'. He requested to either hold back or cut the cost of the following expenses.

Add 4 - 6 TV - \$35,000

Sanctuary carpet replacement - \$10,000 Replacement of 8 doors in Level2 - \$10,464

Treasurer clarified that the \$28,000 was a provision made for a Facility Management staff. He also mentioned that there is a likelihood this will not be spent in 2022.

13.21 Fund Reserves

Mr Rufus commented that by end of year 2022 most of our reserves will be gone and wanted to know how we were going to manage if we ran out the reserves in various funds?

PCC responded as follows:

- a. Trust God our provider
- b. Conduct mid-year review to reduce the gap between Income & expenses.
- c. Review ways to increase income and reduce expenses.

Mr Rufus requested for the oncoming PCC to review the expenses and look for ways to increase the income.

Mr Alfred Ponniah remarked that depleting the reserves is a serious concern. He suggested for a Financial Task Force to be formed including church members with related background or to deliberate within the PCC to investigate the expenses as well as look at ways to manage the cost and increase income.

The Treasurer responded that the Finance Committee will study the suggestion of forming a Task Force and follow up accordingly.

13.22 Income from the New Building

Mr Rufus queried if we are expecting donations from usage of the new building for 2022. Building Committee is in discussion with Prison Fellowship Singapore for use in 2022.

13.23 Interest Free Loan from Diocese – 1 million

13.23.1 Mr Moses Abraham noted that there is no projected income in the budget for the repayment to be made within the next 5 years.

The Treasurer responded that the Loan Repayment works out to about \$16K a month for 5 years which will commence 1 year after the TOP. Provisions for loan repayment will be made in the 2023 budget. Fund raising activities and initiatives will continue.

13.23.2 Mr Aaron Masih also wanted to know if the Redevelopment Fund Raising Committee has mid-term or long-term plans to raise the funds to repay the loan.

Mr Christopher Samuel, the Chairman of the Redevelopment Fund Raising Committee iterated that the Redevelopment Fund Raising Committee will continue to conduct fund raising activities to raise the funds for the next five years.

13.23.4 Mr Suresh, the Building Committee Convenor added that the Fund-Raising Committee will continue its efforts to conduct activities and initiatives to raise funds. Building Committee on the other hand is also exploring contingency plans for the repayment. For example, Agape has extended its usage which includes the previous EAST Asia library space resulting in an increase in their monthly donation. This donation can be channeled towards the loan repayment provided there are no major expenses for repairs to be undertaken.

Mr Rufus pointed out that the 2022 budget is on deficit hence Church members must contribute towards the General Fund and the Mission Fund to balance off the deficit while the repayment of the loan should depend on donations generated by the new building.

13.24 Parish Constitution

Mr Aaron wanted to bring to the attention of the members of the AGM and the PCC on the proposed amendments/review of the Constitution since its last implementation in 1954. In particular, the following 3 Paras for consideration:

- 1. Part A, II (a), Pg.1 of the Constitution states that, "To take counsel in all matters which concern the welfare and progress of the Tamil Church and the congregation in general." I would like to propose that this be amended for the purpose of staying aligned to the ethos and vision of the Parish to develop the spiritual growth of individuals across race and denominations that it be called as an Indian Church and Parish. In this way, we embody, for purpose of inclusiveness the entire Indian community since it has now morphed into 6 different congregations. This is also to align the belief and ethos of the Diocese since our Vicar is also appointed as the Chairman of the Singapore Anglican Indian Board and not just solely for one particular race/denomination.
- 2. Part A, III (a), Pg.1 of the Constitution does not make provision for the Synod Members which has been in practice for some decades in the Parish. I believe we have appointed 3 members with a term of 3 years in Office. It would be good to articulate their roles and responsibilities into the Constitution for purpose of awareness for all members.
- 3. Part C, Page 6 & 7 of the Constitution is redundant since even the closure of the Christ Church Kindergarten. Perhaps the role of the Christ Church School Management Committee could be reviewed for other more purposeful roles in the Parish since there is neither a School nor a Kindergarten

PCC responded that Diocese initiated the review of Parish Constitution in 2019 for all parishes to adopt and implement. The processes have been delayed due to COVID-19. We are awaiting further guidelines on this from Diocese. These suggestions / concerns will then be reviewed/included accordingly.

13.25 Preliminary Points on timelines for AGM 2021

Mr Rufus Ravindran referred to the preliminary points on timelines for AGM 2021 & Dissemination of Reports Dissemination of Annual Reports Via Email. When he registered for the AGM online, he noted that he received the Annual Reports via email almost immediately. This suggests that no one verified whether a person who registers, is a member in the electoral roll, before the Annual Reports were sent via email. Why were Annual Reports disseminated before doing the verification? What is the current procedure?

PCC responded that the VAGM Committee reviewed all due processes and came to a conclusion to continue with the same process as the previous year. Following which all AGM related activities are verified, ensuring only Electoral members can participate in subsequent AGM related activities. This process also allows all church members to have access to the Annual Report regardless of their Electoral status.

Mr Rufus iterated that verification of the Electoral member must be done before the Annual report is emailed.

Mr Alfred remarked that during Pre-Covid he has observed members leaving AGM reports in the canteen after collecting it. Also, there are churches who publish their AGM reports on their website. It is a report that

records what has been done that has a transparent process. He opined that making the AGM report available in the current procedure is acceptable.

The Hon Secretary explained that this is the 3rd year the VAGM has been following this process. They have reviewed the process each year and fine-tuned it where necessary. Also, there has been no instance in the last 3 years where we have received registration from outsiders. VAGM Committee has also studied the practices from other churches on how AGM reports are disseminated before adopting a process that is suitable for Christ Church for example, St Andrews Cathedral publishes the AGM report on its website for the AGM period. The intention is to provide the AGM report as soon as a member registers and also for non-electoral Christ Church members to have access to the report.

Mr Rufus iterated that he had raised this concern because some matters discussed are sensitive e.g.: mission activities or financial matters.

13.26 Redevelopment Fund Raising

Mr Rufus said that on the Year 2019 about \$7000 was invested on non-perishable items for golf tournament. What happened to these items and what is the plan?

Redevelopment Fund Raising Committee responded that the items are with us and there are plans to repurpose the items.

13.27 Hon Secretary's Report

13.27.1 Mr Rufus referred to item 6.0 CLERGY, PASTORAL STAFF AND OFFICE UPDATE. He asked who is the Priest /Pastor in charge of Tamil service because it is not mentioned.

PCC responded that it is Vicar, Rev Canon Steven Asirvatham.

13.28 Church Services (Hon Secretary Report)

Mr Rufus referred to 9.0 of the Secretary's Report.

9.0 CHURCH SERVICES

Enhanced precautionary measures were imposed by CPRO on religious services and activities during the year through Heightened Alerts. These measures were implemented accordingly. Leadership also decided to effect temporary closures between 16 May 2021 to 13 Jun 2021 [Based on Heightened Alert issued on 15 May 2021] and 27 Jul 2021 to 15 Aug 2021 [Based on Heightened Alert issued on 20 Jul 2021]. These decisions were taken as a response to mitigate the risk of further community spread of COVID-19. The second closure between Jul and Aug last year was also extended to replace the progressively failing AV system.

Government regulations for May – August 2021

Heightened Alert - May to June

Decrease in capacity for congregational and other worship services from 250 persons to 100 persons, without pre-event testing (PET);

Heightened Alert from July through August 2021.

Congregational and other worship services will be limited to 100 worshippers (decrease from 250 worshippers today)

Up to 50 worshippers without PET;

Up to 100 worshippers with PET for all attendees.

Above are the requirements for MCCY.

Mr Rufus' first question was:

Why did the church leaders and Pastors decided to close the on-site Sunday services during this period (May – August 2021)?

PCC responded that leadership closely monitored the increasing number of COVID-19 cases at that time. information was also collected from MCCY and CPRO. These data were then studied together with other factors. Based on the above, leadership decided to suspend services as it was the most socially responsible appropriate response to the pandemic at that point of time. Leadership also provided information as follows:

Rev Edison explained during the service that due to the tighter measures issued by CPRO, leadership has decided to suspend onsite services till further notice.

16/5/2021

During 2021 AGM, Chairman explained the various reasons for the service suspension. Please refer to:

- 2021 AGM Minutes page 4, 2.2 Chairman Message
- 2021 AGM Minutes page 17, 18.2 COVID-19 Safety Precautions

1/8/2021 – Chairman during the service provided some of the factors that were carefully considered before taking the decision to suspend services.

Reasons/Factors considered for suspension of service are as follows:

- 1. Clusters were increasing
- 2. Closure of Markets and Food Centres
- 3. Increase in Unlinked cases
- 4. Location of Christ Church
- 5. Christ Church is a Construction Site Heading towards TOP
- 6. 4 Catholic churches with covid cases that has closed for cleaning and tracing.
- Progressively other Anglican Parishes also suspended their onsite services and have shifted to live-stream services.
- 8. Over 25 schools from Pre-School to Junior Colleges have reported covid cases.

Mr Rufus' second question is:

Q2 One of the reasons given was our church is too close to 2 hospitals? This was not mentioned in the report. How does this affect? Please explain reasoning behind?

Response from PCC:

Christ Church is located between 2 hospitals KKH & TTSH. We are also very near to Serangoon. This increases our exposure and risks as these are densely populated areas with high people traffic and movements which are located at close proximity to our church. This was one of the factors considered as a preventive measure in response to the increasing COVID-19 cases during that period.

Moving forward Mr Rufus opined that government guidelines must be followed for they are strict enough. Hon Secretary explained that Government Guidelines are broad guidelines and it is pertinent for each organisation to make decisions considering factors that are unique to them for example we were also a construction site.

Ms Rachel Kunnasekaran thanked the Church Leadership, Safety Management Team and Media Ministry for making decisions to address the situation to keep church members as the priority to protect them during this period. While we trust in God for His protection, we must also be socially responsible. Mr Daniel Dharmaraj added that the current global situation is unstable, and we must trust in God and be socially responsible.

Mr Rufus' third question has 2 parts:

The second closure between Jul and Aug last year was also extended to replace the progressively failing AV system Part 1. Why did the church leaders not replace the AV system in Jul and earlier Aug?

Response from PCC is as follows: This is the timeline of Audio System Failure and Replacement at Sanctuary Jul-Aug 2021

17/7/2021Sound mixer's fuse blown off, it was replaced and started to work.18/7/2021On Sunday onsite service main amplifier and one of the channels started to peak and went off, also affecting online service for a short while. On the spot we had to cut off the one channel to prevent more damage.25/7/2021Both mixer outputs of the main speakers didn't work. We managed to run live stream using a sub audio out without sound in the Sanctuary.27/7/2021Invited contractors to assess the damage and found the mixer outputs, amplifiers all were damaged due to aging (15-20 years old). All the cabling from AV room to Worship, Choir area were brittle and giving way, except the main and rear speakers which were in working condition. Quotations were requested for equipment replacements and rewiring. This is considered to be a major revamp as the original sound system and wiring was done in 1999. 13.29.1 Question from Mr Rufus Ravindran: Thanksgiving Sunday service on Sep 2021 changed to on-line service. Q1. Why was this omitted from the report? The reason given was the Thanksgiving Auction to be held later on in the day.

13.29.2 Q2 Why was the Auction prioritized over the yearly Thanksgiving Church service? Many church members were disappointed by this decision.

Response from PCC:

- Thanksgiving Tamil service was livestreamed on 5/9/2021, Sunday at 7:30am.
- Thanksgiving Auction took place after the Thanksgiving Service on 5/9/2021, Sunday at 11am
- 2 Onsite Thanksgiving Tamil services were held at 3:30pm and 7:00pm for members to attend.
- Clergy and the Redevelopment Fund Raising Committee reviewed all possible timings to conduct Services and the Thanksgiving Auction. After careful consideration this was the best option for all 6 services to attend Thanksgiving Services as well as participate in the thanksgiving auctioning.

Mr Rufus' strongly opined that Service must be given priority and not cancelled.

13.30 Mr Rufus said that Church Leaders took about 2 months to implement relaxed MCCY guidelines. Q: As per MCCY's regulations, live singing during church service was permitted from as early as end 2021. However, in our church, live singing was only allowed in services from March 2022, what was the reason for the delay? He hoped that moving forward, the Church would be more pro-active and efficient in adapting to Covid-19 / pandemic regulations without undue delay.

Ps Moses Ajay, the Safety Management Officer responded as follows:

A. Safe Distancing Requirements:

Live singing was only allowed if we met the safe distancing requirements from MCCY. Singers must maintain a 3-metre safe distance from the main worshippers. When there are two singers, they need to be 2 meters apart from each other. Considering the design of the Sanctuary and the space limitations and the restrictions, we had to forgo live singing element so that a maximum number of worshippers could attend the service.

B. ART Testing:

When live singing was re-introduced after the Heightened Alert, live singing was only permitted when singers do the ART test at MOH Approved ART Test centres. Cost was a major consideration as we have to support 6 services.

C. Self-Administered ART:

Self-Administered ART was permitted in the beginning of this year (2022). Time is needed to study implications and plan out the processes for each individual worship service to:

perform the test collate the results submit the test results

Accountability of ART Tests, appointing leaders to monitor the testing process, cost impact and the design of our sanctuary which posed as a major space limitation were the reasons for continued use of recorded singing.

Ms Gracious Asirvatham highlighted that the Contemporary Service is held at the multi-purpose room. We fail to understand why we are unable to do what other churches are doing. Safety guidelines provided by the government cannot be implemented in the multi-purpose room because of space and design limitations.

Mr Rufus and Mr Aaron remarked that the PCC must not delay implementations and keep pace with the other churches.

13.31 Youth Ministry

Mr Rufus Ravindran thanked Youth Ministry who were involved in the Skit Productions for children at Christ Church, Myanmar and Nepal.

He noted that an average of 9 - 12 youths were attending the programs regularly for the years 2020 and 2021 based on the reports.

He wants to know what are the things done last year to bring back those not attending the youth program?

PCC responded that based on an earlier query on this matter a meeting was arranged for Mr Rufus Ravindran to meet with the Pastor-in-charge for the youths, Youth Core Team and EXCO on 23/3/2022. A key issue discussed at that meeting was concerning youths who are not regularly attending Church and/or Youth Ministry. The Youth Core Team and Ps Theodore Samraj had answered this question at that meeting. They explained to you the steps they had taken to address and encourage absent and irregular youths to attend youth ministry. The outcomes of these efforts were also shared with you.

The notes of the meeting were emailed to Mr Rufus on 4/5/2022 and hence response for this question was provided on 23/3/2022.

Mr Rufus also asked if the Vicar and new church leaders study the possibility of having a dedicated Youth pastor in our church who can take care of teens, Youth and Young adults.

PCC responded that Chairman and the oncoming PCC will study the feasibility of having a Full-Time Youth Pastor. Several factors have to be carefully considered and determined before we make a decision to have a Full-Time Youth Pastor. We agree and recognise that the teens and youths of today are the future leaders and future generation of Christ Church. Leadership is concerned about our children, teens, youths and young adults. We will take a two-prong approach to address these concerns.

The first prong will be for the Youth Core Team to continue to develop programs for all the youths for their spiritual growth, positive interaction for their Christian development and encourage participation in church level programs, ministries and outreach.

The second prong will be for Leadership to form a taskforce dedicated to developing suggestions and ideas on how irregular and absent youths can be encouraged to attend church and youth ministry.

Christ Church Village to build Christ Church Youths

Parents will require a village to raise a child. The village here in Christ Church will consist of Parents, Church Leadership, Task Force, Youth Core Team, Ministries and Church Members



As recorded, at the meeting on 23/3/2022 the Chairman requested Mr Rufus to come alongside with leadership to help build the youths in Christ Church. When the new PCC is formed, the Chairman will initiate the formation of a Youth Taskforce. He will specify the terms

of reference and composite for this taskforce.

Mr Rufus noted that he had raised this concern because he did not see an increase in the number of youths attending the service/youth program since the last time it was raised.

Hon Secretary thanked Mr Rufus for his willingness to be part of the Youth Taskforce to understand and encourage irregular and absent youths to attend Church and Youth Ministry as well as build our youths.

17.0 Resolutions

17.1 Resolution from PCC

Background

- With the increase in the number of online bank transactions by members, it is observed that sometimes monies are transferred to the wrong fund accounts and church office has to redo the transfer to the appropriate fund account.
- In the record of restricted funds, the PCC has heavier responsibility in the completeness in collections and the matching objective in the use of these funds. In addition, any transfer out of restricted fund is subject to a strict approval process. Any deviation might lead to severe consequences. Hence the PCC should carefully look into the restricted fund in the Church and rectify any error in the classification where necessary.
- Auditor advised the PCC to look into the restricted funds in the church and rectify the classification and recommends that all restricted funds will be released and reclassified to designated funds for ease of operational process with effect from 1 January 2022 via ratification in AGM.

RESOLUTION

This Annual General Meeting approves the recommendation to release and reclassify ALL Restricted Funds to Designated Funds and ratify to reinstate retrospectively from 1 Jan 2022 onwards.

Questions and Opinions posed by the members are as follows:

Mr Rufus	 What is the advantage of reclassifying these funds from restricted to designated? How were the wrong transfers handled last year? How would members know if the transfer is due to wrong transfer by members or funds transferred by PCC?
Mrs Hamsarvardhini Stanley	What is the difference between restricted and designated funds?
Mr Alfred	 How do you confirm that a wrong transfer has taken place and do the necessary to put the money back into the correct account. Is there an audit trail?

B Treasurer's consolidated response to the above questions are as follows:

The General Fund is an Operational Fund while the other Funds such as Mission Fund (MF) and Development Fund (DF) are Restricted Funds.

There are incidents where members intend to transfer money to GF and makes a mistake by transferring the money to the MF or DF. As the MF & DF are Restricted Funds the PCC/Treasurer is unable to transfer Page **18** of **24**

the intended fund to the GF because of the restricted nature of the MF and DF. Hence the advantage is that PCC does not have to wait a year to call for an AGM or EOGM to transfer such funds.

The difference between these funds is that Restricted Funds strictly requires AGM's approval for any form of transfer. Designated Funds on the other hand has restrictions where money in that fund can only be used for specific purpose(s) and funds transfer can be initiated by the governing body for specific reasons with evidence and approval from the donors.

MF and DF are currently Restricted Funds hence any transfer requires approval at AGM. These mistakes can take place at any month and that would mean to rectify the transfers and AGM would have to be called. With this resolution, it will empower PCC to make rectification with processes put in place to show necessary initiation of transfers, approvals and shown as evidence during Audit.

Process taken in 2021 when transfer errors were made by members are as follows:

- Treasurers verified with the church members
- kept relevant documentation and initiated the transfers
- evidence was presented to the Auditor during 2022 Audit

Auditors pointed out that this was wrong accounting procedure. Transfer of funds from Restricted Funds to another can only be initiated after obtaining approval at the AGM. For such errors to be addressed by PCC the funds must be reclassified to Designated Funds. Such transfers will then be reflected in the Audit report under notes.

Mr Rufus' opinions/concerns were as follows:

- Reclassifying the funds would allow PCC to transfer funds from one to another fund when there is insufficient fund? (E.g.: Not enough fund in GF so move money from MF to GF or vice versa)
- 10 years down the road he PCC then will not be able to recall why this resolution was accepted.
- If the issue is that members are contributing to the wrong fund, then the resolution should only be for PCC to be allowed to rectify the wrong transfer instead of reclassifying the funds.
- We should educate members to transfer funds correctly.
- We should not reclassify the funds because of human errors.
- He suggested for the resolution to be specific to address the wrongly transferred funds only.

Mrs Hamsarvardhini's opinion/concerns were as follows:

- Reclassifying the funds to Designated Funds removes the boundaries that were created to protect the funds to be used for a specific purpose.
- It is not advisable, for in the long run long it gives access for funds to be transferred or released to be used for other purposes. It also gives PCC the liberty to move the funds.
- An increase in online transactions is an exception in the last two years. We should not remove the boundaries because of this exception.
- This problem will reduce when members worship onsite.
- Getting written confirmation from donors who had done mistaken transfers should suffice to move funds to the correct funds without reclassifying the funds,

Mr Alfred opinion/concerns were as follows:

- The resolution lacks the mention that this reclassification is being done to address mistaken contribution of funds.
- F Ms Ruelia Rufus suggested the following to address the situation where members are scanning the wrong QR codes causing funds to be transferred to the wrong accounts:
 - Instead of several QR codes have only one QR code and a drop-down box with the several funds for members to select from to reduce any confusion or error.

The Treasurer iterated that this resolution is a recommendation from the Auditor. He will bring the above concerns and suggestions to the Auditors. An EOGM will be convened if needed.

17.2 Resolution from Mr Moses Devadas Abraham and Ms Samuel Dora Pamela

Background

During our recent bereavement on the passing on of my mother, we found it the hard way how inconvenient it was to hold the wake for her at a public funeral parlour in Tampines.

As we have 2 large halls on the ground floor of the new building, I would like to propose that we allocate or

designate 1 of the halls to be used as a Wake Hall by members of our church, if or when a need arises for it. The Family could give a very dignified send off for their dearly departed, having the wake at a very familiar place within the church compound. Of course, there would be cost involved in holding a Wake, and they should be prepared to pay accordingly, for the usage of the Hall just as they would have when using a Public Parlour. Therefore, we seek the support of All the Members of the Church to vote in favour of this proposal.

RESOLUTION

Propose to allow the use of the Hall on the ground floor of the new building, for the purpose of holding a Wake as and when a need arises for members of Christ Church. The use of the Facility shall be charged at a cost to be decided by the PCC.

Proposer: Mr Moses Devadass Abraham Seconder: Ms Samuel Dora Pamela

PCC responded that leadership would form a committee to study the feasibility of this proposal and advice accordingly. Mr Moses asked to carefully consider any feedback from church members on this proposal as he feels strongly that it will be beneficial to Church members.

18.0 Appointment of Vicar's Warden

The Chairman announced that he is appointing Mr V Christopher to continue to serve as the Vicar's Warden for 2022 and he thanked Mr V Christopher and his family for their support.

APPENDIX 1: Presentation – Nepal Missions by Bro Sandrabose and Sis Vasanthi

Bro Sandrabose and Sis Vasanthi thanked God, Clergy, Pastoral Staff, Church leadership and Church members for their support and prayer in this journey that they undertook to serve as missionaries in Nepal since September 2018.

They briefly shared their personal challenges acclimatising themselves in a new country leaving behind their families, jobs, safety and security of the home country to an unknown country in obedience to God's call they are serving in Nepal. There also shared about the political climate as well as the many risks they experience such as anti-conversion law and anti-Christian sentiments.

Their 2 main tasks from Christ Church, Deanery of Nepal (DON) and the Anglican Churches of Nepal (ACN) are as follows:

- Support Christ Church Pokhara, Church Planting
- Joy Land Kindergarten

1.0 Christ Church Pokhara

They have moved from Hemja to Shantaban and now to another location due to increase in rent. The new rented area is at the city center near the slum areas. Church is growing and Members have been increasing. Children's ministry has extended to include tuition support.

2.0 Joy Land Kindergarten

Currently they are using a rented place in Pokhara, providing administrative, academic, staff recruitment and promotional support to fully operationalise the kindergarten

3.0 Pandemic and Lockdown Update

3.1 Christ Church Pokhara

They shared the many miracles God performed while they were in Nepal during the Lockdown and return to Singapore. People have suffered tremendously with the lockdown. They have continued to support Christ Church Pokhara via Zoom.

3.2 Grace Church, Singapore

They have also provided support to Grace Church in Singapore which is a Nepali community. They have supported this church with counselling, prayers, teachings etc...

3.3 Nepal Deanery

They have continued to support the deanery with administrative matters by attending Zoom meetings.

3.4 Nepal Medical and Food Relief

They have facilitated the DON and ACN with their Medical Relief from May to July 2021 by coordinating fund raising efforts and the purchase of oxygen concentrators from Singapore to be delivered to Nepal. Families have lost their livelihood and do not have sufficient food. Funds were collected and sent to Nepal to purchase food supplies such as rice and oil for those who are struggling.

3.5 Joy Land Kindergarten

School was closed due to the pandemic and efforts have been taken to restart the kindergarten with the support of the government approval. Owner was demanding high rent and had to seek for an alternative location to restart the kindergarten.

3.6 Return to Nepal after the Lockdown

When the Covid restrictions was relaxed Bro Sandrabose and Sis Vasanthi returned to Nepal in November 2021 to:

- resume their mission works
- continue with works that were halted due to the pandemic such as the administrative work for the purchase for some of the churches such as the Golgotha Church at Hattiban, Nazarene Church Land and Mulpani Church.
- conduct Christmas Outreach Celebrations after 2 years to being about hope and happiness at several churches which encouraged many people to attend the program and services. Many have received Christ and have been baptised too.
- Conduct training and provide administrative support for ACNMeet with and support other ACN Churches and childcare centres with resources.

4.0 Permanent Location for Christ Church Pokhara and Joy Land Kindergarten

We thank God that He has answered our prayer of almost 5 years for a permanent location. The cost is S\$250,000. The land area covers 5000sf and has an existing 3-story building. There are plans to include a worship hall, ministry room, multipurpose room, vicarage, open terrace, 2nd Joy Land kindergarten. May include an additional storey. Fund raising efforts will commence and there will be more details at a later date.



4.3 Questions and Answers on the Presentation

A Mr Moses Abraham queried on how receipts and expenses will be presented in the General Fund in the future.

Mr Mahendran explained that based on accounting principles and audit guidelines provided by ACRA in the recent years all transfers must be presented in a separate table in the Audit Report. This is exactly what we have been doing which can be seen in the past Audit Reports.

- **B** Mr Kingsly clarified that Mr Moses' suggestion for fund transfers are as follows:
 - 10% mission tithing transferred from General Fund to Mission Fund should be captured as an expense in General Fund and as income in Mission Fund
 - 10% mission tithing transferred from Development Fund to Mission Fund must be shown as an expense in Development Fund and as income in Mission Fund

Mr Kingsly further explained that in the past this was the practice until the City Harvest Accounts Irregularities. After the City Harvest incident, the accounting principles required any transfer between funds in an organisation to be transparent and be captured separately in the Audit Report.

- **C** Mr Mahendran explained that quota given to the Diocese is funds that is outgoing hence it is reflected as an expense from General Fund.
- **D** Mr Mahendran and Mr Kingsly confirmed that based on accounting principles we are unable to record transfers between funds in the church as an expense. The audit presentation cannot be changed.
- **E** The funds were classified as unrestricted up until 2020 when the previous Auditor classified Mission Fund and Development Fund as Restricted Funds because of the City Harvest incident. The current auditor highlighted that based on the nature use of the funds both Mission Fund & Development Fund must be reclassified.
- **F** Chairman iterated that these recommendations also are in line with the guidelines provided by the Finance Board to all the Treasurers.
- **G** Mr Aaron Masih thanked Mr Mahendran for the comprehensive presentation and acknowledged that it was a good initiative to reclassify the funds from restricted to designated funds. He requested for information on the addendum to the Mission Policy.

Mr Mahendran explained that the Addendum specifies restrictions to the use of the Mission Fund which will be presented in the next part of the EOGM. These controls are put in place as a check and balance on the use of these funds

H Mr Aaron wanted to know the types of mission activities Mission Fund can be used for.

Mr Mahendran referred him to the Mission Policy which was presented at the AGM in 2021 which clearly defines what constitutes mission activities. He can approach the Mission's Convenor or the office secretary for a copy of the policy. Mr Mahendran elaborated on one of the Mission activities carried out during the Pandemic to reach out to the staff at KK Hospital to encourage them to show them our appreciation, care and concern. This act of kindness will bear fruits at its opportune time.

- I Mr Moses wanted to know how the organisation expenses will be managed.
 - Mr Mahendran explained that the: -
 - organisation fund is subsumed in the General Fund

- organizational activities will carry on as usual
- income and expenses done by organisations (Functional Groups) will be shown as separate line item in the General Fund
- J Mr Moses queried why Mission Fund cannot be subsumed into the General Fund like the Organisational Fund.

Mr Mahendran explained that while he is not aware of the origins of the Mission Fund, he believes that our Forefathers must have purposefully created a separate fund intending for Christ Church to be a missionoriented church actively supporting missions. A dedicated committee was formed and subsequently a policy handbook guiding Missions and Evangelism Committee was formed to provide clarity, transparency and control. He believes that the Mission Fund has been around for almost 20 years or even longer.

- **K** Mr Mahendran wanted to clarify if Mr Moses' stand is for the Mission Fund to be removed. If that is so, then why Mr Moses did not raise his concerns when it was first established and is raising it now.
- L Chairman said that he believes that our Forefathers must have wanted Christ Church to be actively involved in missions. Church of the Epiphany, missions and missionaries supported in Singapore, India, Nepal and other parts of the world are testimony to the way God has led us in serving Him in this area.
- **M** The concern Chairman sees here is accountability and that funds are not simply transferred without a reason or justification by PCC. Those who serve in the PCC are elected by the members and it is imperative to trust that they will not frivolously or carelessly handle church administrative or financial matters. Chairman further iterated that one of the key strengths of Christ Church is that there is proper accountability and funds are managed carefully. Chairman added that the Diocesan Finance Board assessed our accounts in the last two years and commended us for managing our funds and accounts well. There are additional guidelines from ACRA and Diocese for us to comply with which provides for further transparency and at the same time limits us to present the accounts in a certain manner.

4.4 Concerns Raised at 2022 AGM

The Hon Secretary shared the following key concerns and questions raised by members at 2022 AGM:

- Reclassifying the funds would allow PCC to transfer funds from one to another fund when there is insufficient funds? (E.g.: Not enough fund in General Fund so move money from Mission Fund to General Fund)
- 10 years down the road, the then PCC will not be able to recall why this resolution was accepted.
- In the long run it gives access for funds to be transferred or released or to be used for other purposes. It gives PCC the liberty to move the funds.
- Reclassifying the funds to Designated Funds removes the boundaries that were created to protect the funds to be used for a specific purpose.

5.0 Reviewed Resolution

5.1 The amended motion is as follows:

RESOLUTION

This Extra Ordinary General Meeting approves the recommendation to release and reclassify the below mentioned Restricted Funds to Designated Funds and ratify to reinstate retrospectively from 1 Jan 2022 onwards:

- Development Fund
- Mission Fund

5.2 Addendum

Further to the above Resolution an Addendum is included to the existing Mission Policy.

ADDENDUM 1 - TO THE MISSION POLICY

- 1. Funds should not be transferred from Mission Fund or utilized other than the mission activities recommended by the Mission committee and approved by the PCC.
- 2. For any transfer to non mission activity should be tabled in the AGM or EOGM of the Parish of Christ Church and approved by the members of the AGM or EOGM.
- 3. Above rules and regulations should be strictly adhered to without any deviation

5.3 Question and Answers

A Mr Moses stated that the addendum is only for the Mission Fund. He wanted to know if fund movements from the Development Fund to other funds would be tabled at the AGM for approval.

Mr Kingsly responded that the Development Fund is a Designated Fund which PCC can decide. Mr Mahendran further added that there should not be any transfers from Development Fund to General Fund. Development Fund being a Designated Fund will only be used for matters concerning the buildings.

B Mr Moses stated that funds have been transferred in the past from Development Fund to manage deficit in the General Fund. Should there be insufficient funds in the General Fund what is the process of transferring funds.

Responses from Mr Mahendran and the Treasurer are as follows:

- funds were **ONLY** transferred from the Development Fund to support the Kindergarten Fund.
- should there be a cashflow issue in the future, there is a possibility for funds to be transferred from the Development Fund to the General Fund for pressing needs to pay for key expenses such as salaries. PCC will make the decision to transfer funds.
- church is expected to have 6 to minimum 3 months reserve in the General Fund to manage operation expenses. This is monitored at every PCC meeting, and we have been maintaining it thus far by God's grace.
- If PCC foresees a deficit in the next few months, Vicar will bring it to the attention of the members or inform through an EOGM.
- during the Pandemic, we did not transfer funds to the General Fund. Finances were managed carefully, and we had reserves to fall back on. Most importantly, by God's grace members gave sufficiently to cover all major expenses.
- In the past 3 years we did not have deficits, we did not blow up the budget and God's providence carried us through the most difficult of times by faith.

In response to Mr Moses, Mr Ravindran Rufus also confirmed that according to his knowledge **no money** was transferred from Development Fund to General Fund. Money has been transferred from Redevelopment Fund to Mission Fund and then from Mission Fund to Kindergarten Fund.

C Mr Moses noted that we have an interest free loan of \$750, 000 to repay to the Diocese. With no funds coming into the Redevelopment Fund, no revenue generated through activities, we may use the revenue from the Development Fund to pay the loan. He noted that according to him that is considered movement of money from one fund account to another. He wanted to know if this will be tabled at the AGM for approval.

Mr Mahendran explained that the Redevelopment Fund is a Restricted Fund created solely for the purpose of managing the new building. After the completion of the building and all the payments are made, this fund has to be closed. The balance funds if any will be transferred to the Development Fund. Development Fund would have to take over the Asset as well as the liability of the fund. All donations if any from this building will go into the Development Fund which will be managed by the Building Committee. The loans will then be paid from the Development Fund.

D To the query from Mr Moses if the Redevelopment Fund can be closed without fully repaying the loan in the next 5 years,

Mr Mahendran mentioned this query will be verified with the Auditors. The decision has to be made based on the ACRA guidelines and the Auditors. The Hon Secretary further confirmed that the Fund-Raising activities will continue to generate funds to pay off the loan.

E Mr Ravindran Rufus explained that since the City Harvest Incident, resolutions at the AGM have been presented for fund transfers and Mr Moses is asking if this practice can continue? Based on the budget we will be able to understand which funds would have a deficit and surplus and therefore PCC could submit a proposal at the AGM.

Mr Mahendran iterated that whenever there is a deficit in any of the funds, Vicar will inform the members to address the situation and if there is a need or an EOGM will be called to table a resolution accordingly.

5.4 Voting

6.0 Closing Address and Prayer

On behalf of the PCC the Chairman thanked all the members across all the services for taking the time to be present at the EOGM.

He explained that the EOGM was being held on a Saturday as services are held throughout the Sunday. Many new members are attending, and do not want to disrupt these services.

He also requested for prayers for the oncoming AGM in April.

He encouraged all to be thankful for God's blessings and to continue to trust in Him in all our challenges.

The EOGM ended at 6:25pm with closing prayer by the Chairman.

INDIAN FRIENDS TAMIL MINISTRY

"Therefore, go and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything I have commanded you. And surely, I am with you always, to the very end of the age." (Matthew 28:19-20)

We praise, thank and give glory to our Lord Almighty for his abundant blessings till today in this ministry. IFTM has completed 23 years and is marching on successfully. This ministry was started by a few brothers in Feb 2000, with only 5 IFTM members attending then. But as our God is a faithful God, an average of 150 - 170 people, including some nurses and few families, attended the Sunday services in 2019.

Due to COVID19 shutdown, we started conducting the Sunday Services through Zoom from Jul 2020, which was attended by an average of 45, including the IFTM brothers staying locally in Singapore, nurses, few families and some IFTM brothers (those who gone back to India) joining from India. Since the Covid restrictions eased the IFTM onsite services commenced from 19 Apr 2022. An average of 70 to 80 people started attending the onsite services. The Word of God is shared by Rev Edison N Wilson, Pastor Theodore Samraj, Bro Thomas Javaseelan and Bro Kalaikumar.
